We respect your privacy and process your personal data only for the purposes for which you have shared it. In this privacy statement, we aim to make it clear what personal data we collect and store and for what purpose.

## 2 Data Controller

## 3 Definitions

- SNIc 2025: The conference organized by Stichting Nationaal Informatica Congres on November 25th 2025 and the organizational committee behind it. Hereafter also named “SNIc 2025”
- SNIc committee: the organization behind SNIc 2025. Can also be referred to as “the SNIc 2025 organization”
- Participant: Visitor of SNIc 2025, who is in possession of a valid ticket provided by their study association.
- Partner: company or other organization (financially) contributing to SNIc 2025

## 4 Processes involving personal data

To organize SNIc 2025, several processes require the collection and use of personal data. Each process is carried out on one of the following legal bases as defined in Article 6 of the General Data Protection Regulation (GDPR):



- Consent (Article 6(1)(a)), when a participant voluntarily provides information, such as for resume sharing, QR-code exchanges, or appearing in photos and videos.
- Contractual necessity (Article 6(1)(b)), when data is required to organize participation in the event, such as registration details and track sign-ups.
- Legitimate interest (Article 6(1)(f)), when processing is necessary for the proper organization and promotion of the conference, and does not override participants' privacy rights.

## 4.1 Registration for SNiC 2025

When registering for SNiC 2025, either as a participant or as someone else, one has to provide their personal details. This data includes at most: name, email address, study program, dietary wishes, special needs, spoken languages and study association. Those details will be stored in the SNiC 2025 website database. These details will be used to identify users during the conference.

Legal basis: Contractual necessity

## 4.2 Registration for tracks

To register for the tracks, participants need to use their personal account on the SNiC 2025 website. The website will register who registered for which tracks. This information is only visible to the corresponding participant and the committee.

## 4.3 Resume for speed dates

As preparation for the speeddates, participants can send their resume beforehand to SNiC 2025. SNiC 2025 will then share these resumes with the partners present at the speeddates. The committee will request these partners to destroy the shared resumes once SNiC 2025 has taken place.

Legal basis: Consent

## 4.4 Voluntarily sharing details with companies

During SNiC 2025, participants may choose to share their contact details with partner companies by showing their personal QR code.

When a participant does so, the company receives the participant's name, email address, and study program for the purpose of contacting them after the event.



This exchange happens only when the participant explicitly presents their QR code, meaning the participant actively consents to this data transfer.

After the data has been shared, the company becomes the data controller for this information and is responsible for processing it in accordance with its own privacy policy.

Legal basis: Consent

## **4.5 Photos and video recordings**

During SNiC 2025, photos and video recordings will be made of the conference. By attending the event, participants acknowledge that they may appear in these photos or videos. After SNiC 2025 has taken place, these photos and videos will be shared on the social media channels of SNiC. These photos and videos may also be used by future SNiC conferences for promotional reasons.

Legal basis: Legitimate interest.

Consent withdrawal: If you wish to have a photo or video removed, please contact the SNiC 2025 organization.

## **5 Processing by third parties**

### **5.1 Caterer**

To adhere to the dietary wishes of all people present at SNiC 2025, the dietary wishes of everyone are collected. The caterer will receive a list of different dietary wishes and how many people have these wishes. This personal information is therefore shared anonymously.

### **5.2 Event Venue**

To adhere to the needs of all people present at SNiC 2025, the needs of everyone are collected. The event venue will receive a list with this information. This personal information is therefore shared anonymously.

### **5.3 Study associations**

During the period between sharing ticket codes and the SNiC 2025 conference, the SNiC 2025 committee will share the list of registered participants with their corresponding study associations. This gives each study association a list of who still has to activate their SNiC 2025 ticket.



## 6. Security of Personal Data

We take appropriate technical and organizational measures to protect your personal data against unauthorized access, loss, misuse, or disclosure. This includes limiting access to personal data, storing it in secure systems, and using encrypted connections for data transmission.

## 7. Data Retention

SNiC 2025 does not retain personal data longer than necessary. All personal data will be deleted at most three months after the SNiC 2025 committee has been discharged, and in any case before February 1st, 2026.

## 8. Your Rights

Under the GDPR, you have the following rights regarding your personal data:

- **Right of access:** to see what data is stored about you.
- **Right to rectification:** to correct incorrect or incomplete data.
- **Right to erasure:** to have your data deleted ("right to be forgotten").
- **Right to restriction of processing:** to limit the use of your data.
- **Right to data portability:** to receive your data in a structured format.
- **Right to object:** to object to processing based on legitimate interest.
- **Right to withdraw consent:** if processing is based on consent (e.g., resumes, photos), you can withdraw it at any time without affecting prior processing.

To exercise these rights, please contact the SNiC 2025 organization using the email address on the contact page of the SNiC 2025 website. Please note that if you request deletion of data that is necessary for event participation (such as registration details), SNiC 2025 may not be able to provide access to the event.



## 9. Complaints

If you have a complaint about how your personal data is processed, you can contact us via the SNiC 2025 website. You also have the right to submit a complaint to the Autoriteit Persoonsgegevens (Dutch Data Protection Authority).
